- Motion by Page, second by Edmonds: offer 2 year contract to Steve Meadows for 2020-2021 and 2021-2022 seasons
- Vote: passed unanimously

## Job Board

- Motion by Zorn, second by Edmonds: establish a classified section/job board on the KHSSL website for coaching positions and judging opportunities
- Vote: passed unanimously

#### School Membership Fees

- Motion by Martin, second by Robinson: modify the dues structure
  - \$100 for speech, \$100 for debate by November 1
  - \$150 for speech, \$150 for debate after November 1
- Vote: 11 in favor (Randolph, Page, Bonneau, Feldhaus, Robinson, Allen, Stamper, Edmonds, Martin, Cecil, Combs), 2 opposed (Zorn, Reeder), 1 abstention (Hagans-Flores) - Motion Carried

### Junior Participation at Senior Invitationals

- Motion by Cecil, second by Feldhaus: add language to the handbook that clarifies that junior division schools may compete at senior division invitationals at the discretion of the tournament host
- Vote: passed unanimously
- It should be noted that this does not constitute a change but rather confirmation of what is currently in practice.

# Duo Interpretation

- Motion by Cecil, second by Feldhaus: add the following statement to rule #5 and ballot guideline #4 that reads
  - Except in the introduction, no touching is allowed.
- Vote: passed unanimously
- Motion by Cecil, second by Martin: add the following statement to rule #4 and ballot guideline #3 that reads
  - Except in the introduction, students may not make obvious eye contact with one another.
- Vote: passed unanimously
- It should be noted that neither of these statements constitute a change but rather confirmation of what is currently in practice.

### Oratory/Informative

- Motion by Martin, second by Zorn: schools no longer need to submit speeches to Regional/State tournaments but rather have them available if challenged
- Vote: 12 in favor (Randolph, Page, Bonneau, Reeder, Hagans-Flores, Robinson, Zorn, Martin, Feldhaus, Stamper, Combs, Cecil), 1 opposed (Edmonds), 1 abstention (Allen) -Motion Carried

#### Improvisational Duo

- Motion by Cecil, second by Robinson: poll the membership by June 15 on proposals 1 and 3 to be discussed at special called board meeting
- Vote: passed unanimously

#### KHSSL Co-Sponsored Tournaments

- Motion by Robinson, second by Martin: accept proposal to offer schools in underserved regions to apply for KHSSL-assisted invitationals, provided that no school has hosted a tournament in the past two years with the same head coach in place
- Vote: passed unanimously

### Tournament Results

- Motion by Cecil, second by Hagans-Flores: add language to the handbook that invitationals are encouraged to publish results by the Monday following the tournament
- Vote: passed unanimously

# Regional/State Deadlines

- Motion by Page, second by Edmonds: accept proposal to change deadlines with the following modifications:
  - Regional tournament 12pm Wednesday changed to 8pm Tuesday
  - State speech: all 12pm references changed to 8pm
  - State debate: all 12pm references changed to 8pm; registration deadline two weeks before the tournament
- Vote: passed unanimously

## Section Size for Regional Tournaments

- Motion by Cecil, second by Robinson: omit rules 13 and 14 under regional tournaments in the handbook and replace with language specifying that the goal is to have six students per section, no more than seven
- Vote: passed unanimously

#### Invitational Tournament Rules

- Motion by Cecil, second by Randolph: accept proposal for KHSSL-sanctioned tournaments
- Vote: 12 in favor (Randolph, Page, Edmonds, Reeder, Hagans-Flores, Robinson, Zorn, Martin, Feldhaus, Stamper, Allen, Cecil), 1 opposed (Bonneau) Motion Carried

#### Tournament Schedule

- Motion by Robinson, second by Cecil: approve the tournament calendar with the following edits
  - KHSSL Junior State to be held on Feb. 26-27
  - SCAPA Junior Invitational to be held on Jan. 16
- Vote: 11 in favor (Randolph, Page, Allen, Reeder, Robinson, Zorn, Martin, Bonneau, Stamper, Edmonds, Cecil), 1 opposed (Hagans-Flores), 1 abstention (Feldhaus) -Motion Carried

#### Elementary Division

- Motion by Cecil, second by Page: accept proposal as written to allow elementary schools to participate at a reduced level
- Vote: 9 in favor (Page, Bonneau, Reeder, Robinson, Zorn, Martin, Edmonds, Cecil, Feldhaus), 3 opposed (Allen, Stamper, Randolph), 1 abstention (Hagans-Flores) -Motion Carried
