- Evaluation instrument will be used beginning with the next Executive Director contract

#### Hall of Fame

## Judge Training

- Motion by Zorn, second by Robinson: require anti-bias judge training form to be completed by all Regional and State judges
- Vote: passed unanimously

## Judge Instructions

 Motion by Robinson, second by Page: edit the ballot instructions to remove the following language "Focus on the performance, not the piece" and "The suitability of the material to the maturity level of the performer should be considered"

## and replace with

"Students will perform material that may be controversial to some audiences, but that's an important part of growing and learning and engaging in important dialogue in our communities.

Therefore, students should never be punished for tackling difficult or controversial topics. However, it's certainly possible that the student who is tackling that controversial topic is not adequately conveying the message in a believable way. This could be due to maturity level."
